## INSTRUCTIONS & INFORMATION FOR OBTAINING A WELL PERMIT

1. Applications, along with the \$75.00 fee (made payable to CENTRE TOWNSHIP), shall be submitted to:

Normal office hours are Monday through Friday, 8:00-4:00. VOICE MAIL is available 24 hours a day, seven days a week, for those wishing to leave messages during non-business hours.

- 2. A plot plan must be included with the application. The plot plan shall be a "to scale" drawing. The following information shall be included on the plot plan (this is the minimum information, should the site have unique characteristics, additional information may be required.)
  - a. the location of the proposed well
  - b. ALL property lines
  - c. dimensions from the proposed well to the lot lines
  - d. all existing structures and physical features (roads, other buildings, wells, sewage systems, driveways, etc...) currently on or adjacent to the property.
- 3. Proposed well construction information must be provided.
- 4. Upon receipt of the completed permit application and all other supplementary information as listed above, the permit application will be reviewed. Typically within seven (7) to ten (10) days of submittal to the Ordinance Enforcement Officer, the application will either be approved or denied in writing.
- 5. Should there be any questions or help needed in the completion of the application, feel free to contact the Ordinance Enforcement Officer for assistance.

## **NOTICE!!**

The well driller shall verify all dimensions before drilling/installation begins. Ultimate responsibility for compliance with all applicable standards and ordinances lies with the property owner.

PLEASE NOTE- Centre Township Schuylkill River Stormwater Management Ordinance conformity is required prior to issuance of this permit. The applicant should contact a consultant (i.e. engineer) to prepare the necessary information to demonstrate conformity to that Ordinance, and the Township engineer must review and approve prior to permit issuance.
